

Accreditation of IMTA International Mountain Hiking Tourism Demonstration Route

I. About IMTA International Mountain Hiking Tourism Demonstration Route

This global call for mountain hiking tourism demonstration routes is based on the indicator system of the *International Mountain Hiking Tourism Guide* compiled by the International Mountain Tourism Alliance (IMTA). It's geared towards the design and development of hiking tourism products that are of benchmark significance, from a high starting point, with high standards, and in an internationalized manner. It is expected to drive the sound development of hiking tourism and provide a model and international standard for the industry.

IMTA International Mountain Hiking Tourism Demonstration Route will be a brand name and a symbol of quality for hiking products in the future, providing technical support and help to hiking tourism operators and hiking enthusiasts. The brand image and market value of any tourism destination that has been accredited as an IMTA International Mountain Hiking Tourism Demonstration Route will be enhanced. It will thus become a great promotion tool for the development of hiking tourism.

The criteria for accrediting an IMTA International Mountain Hiking Tourism Demonstration Route will be a valuable code of practice or a source of specifications for the planning, creation, operation, and enhancement of hiking trails. Moreover, it can also be a model for regions that are interested in developing hiking tourism products, with a view to contributing to the systematic and standardized development of the hiking tourism industry.

II. Accreditation Procedures for IMTA International Mountain Hiking Tourism Demonstration Route

There are two phases in the procedure for accrediting an IMTA International Mountain Hiking Tourism Demonstration Route:

1. The interested destination completes the application form and submits it to IMTA. IMTA will appoint experts to train the hiking product operating entity at the declaring destination so that it will have a detailed understanding of the procedures and conditions for

the accreditation, enabling the declaring entity to make the necessary preparations and responses, and to submit detailed declaration materials.

2. The declaring entity submits the declaration materials to IMTA, which will proceed with the evaluation and review. For a destination that meets the declaration requirements, the IMTA International Mountain Hiking Tourism Demonstration Route accreditation will be granted for a period of three years.

IMTA will organize regular re-examinations and reviews of the demonstration route in accordance with the criteria. The destination may opt for an annual review of renewal or an all-encompassing review on a triennial basis. The destination may extend the certification for a further three years after the expiry of the three-year period. All destinations that have been accredited as demonstration routes must reapply after six years to ensure their fulfillment of the most up-to-date quality criteria. Any destination that fails to meet the criteria in the review or re-examination and does not rectify the situation within the time limit will be "de-licensed".

III. Accreditation Principles of IMTA International Mountain Hiking Tourism Demonstration Route

1. With premium mountain hiking tourism route resources, with hiking trails or with the conditions to develop hiking trails.

2. With acknowledgement and acceptance of the development of mountain hiking tourism trails, of the development of mountain hiking tourism products or of the upgrading of existing trails under the guidance of the *International Mountain Hiking Tourism Guide*.

3. With the agreement to complete the construction, adjustment, standardization and upgrading of mountain hiking tourism products in accordance with the *International Mountain Hiking Tourism Guide* within one year after receiving the license from the demonstration route.

IV. Criteria for IMTA International Mountain Hiking Tourism Demonstration Route (draft)

The demonstration concerns all or parts of domestic/cross-border hiking routes, with a minimum length of 50 kilometers and a daily hiking itinerary divided into at least three sections. The route shall be evaluated in each of the following two dimensions:

1. Consecutive sections of 4 kilometers in length (about an hour's walk each)

Each section shall be examined according to the following 23 optional criteria and then scored. 1 point for each criterion met. For a 50-kilometer route or more to receive the corresponding certification, all the related sections must score at least 11 points.

2. The evaluation shall be performed in accordance with the mandatory core criteria along the trail for the daily section and the entire route.

For example, a 200-kilometer route might receive the certification for its entire length, or only one or a few sections that are longer than or equal to 50 kilometers might be certified, or it might be unacceptable because the premium sections are too short and/or not consecutive

The evaluation system and criteria are listed below:
